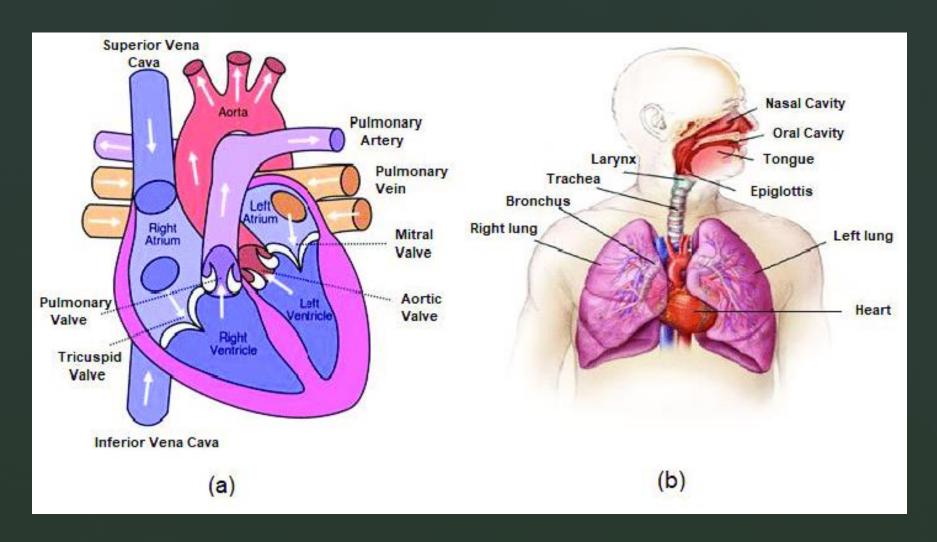

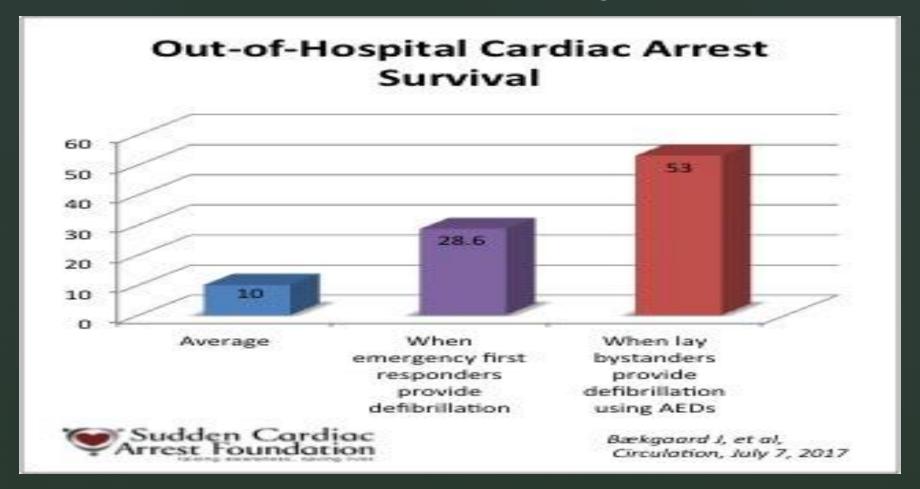

INTRODUCTION

- The cardiovascular (heart) and pulmonary (lungs) systems work in tandem to sustain life. Their function is reflected in our vital signs:
 - Heart Blood Pressure (BP), Pulse
 - Lungs Respiratory Rate (RR), Oxygen Saturation (SpO₂)
- These indicators guide emergency interventions like CPR, which supports both circulation and oxygenation when the body's natural systems fail.
- CPR is a life saving procedure performed when the heart stops beating (cardiac arrest) or when breathing has ceased with the aim of maintaining circulaiton of oxygen-rich blood to the brain and vital organs of the body until advanced help arrives or the heart can be restarted.

Problems: A Race Against Time

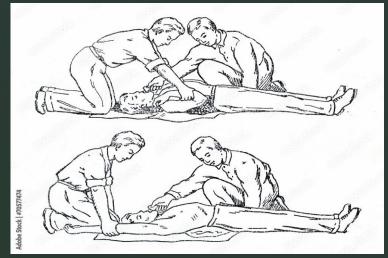


Every second counts. Your actions in the first few minutes are the single greatest determinant of survival."

History

- Pre 20th century: Bellows :Barotrauma
- Mouth to Mouth
- Silvester Method
- CPR (AHA, 1966)
- We've come a long way from guesswork to evidence-based medicine. The key lesson was realizing circulation was the immediate priority."









Why C-A-B? (not A-B-C) ...the Science of Priming the Pump

- 2010, AHA guideline shifted from A-B-C to C-A-B based on data
- Key Question: Why compressions first?
 - Oxygen is already in the blood. The limiting factor is FLOW. Use the "Bridge to Survival" diagram here.
- Prime the pump to get whatever oxygen left circulate

The Chain of Survival



- Recognition/Activation -> Early CPR -> Rapid Defibrillation -> ACLS,
 Post-Arrest Care -> Recovery).
- CPR is a vital link, but it's part of a system. You are the first and most important part of that system."

Recognition: cardiac arrest?

- The Triad:
 - Unresponsive?
 - No Normal Breathing?
 - No Pulse (<10s)?</p>

Goals

- YOU ARE NOT TRYING TO RESTART THE HEART (Defibrillation) but...
- immediate:
 - Artificial heart and lungs
 - Bridge to definitive treatment
 - Defibrillation, ACLS drugs, securing advanced airway.
- Ultimate:
 - Survival with good neurological outcome





- NB: landmark, body positioning, technique
 - hands, elbow, shoulders

High-Quality CPR: 5 pillars

Rate: 100-120/min

Depth: 5-6 cm (not too deep, not too shallow)

Recoil: Full

• Ratio: 30:2

Minimize Interruptions! (CCF >80%).

"These are not suggestions; they are evidence-based targets. Quality trumps speed."

CPR for different age groups

	Age group	Head tilt	Type of breath	Hand positioning for compression
	Baby	No head tilt	A small puff	2 fingers only to a depth of 2 cm
	Child (1–8 years)	Half head tilt	Half a breath from the lungs	2 hands (1 used only for support) to a depth of 3 cm
	Adult	Full head tilt	Full breath from the lungs	2 hands to a depth of one third of the chest

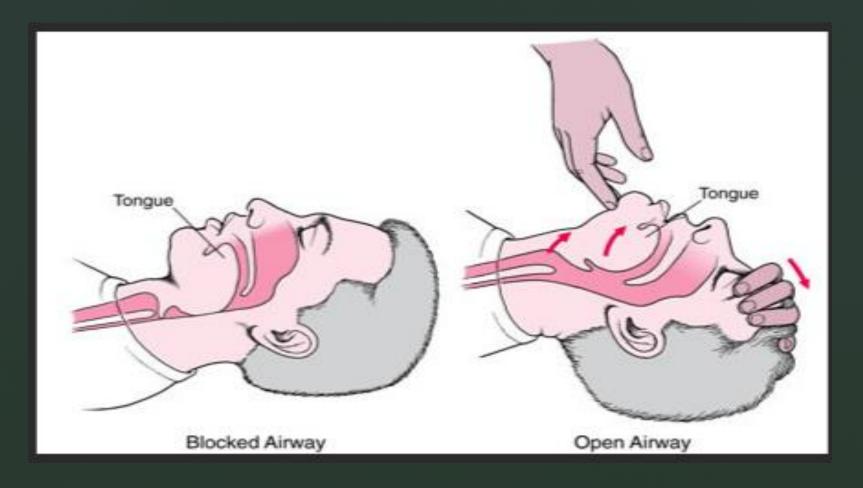

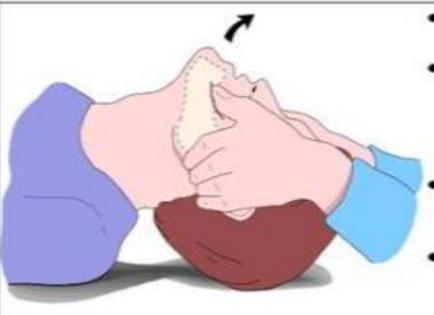
Technique: Airway & Breathing



Head tilt and Chin lift

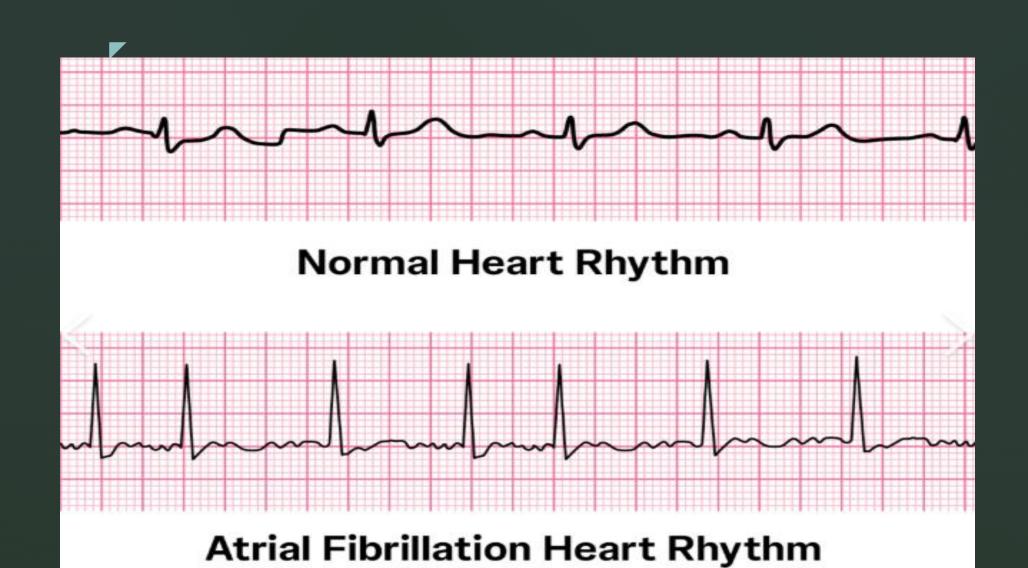
Technique: Airway & Breathing

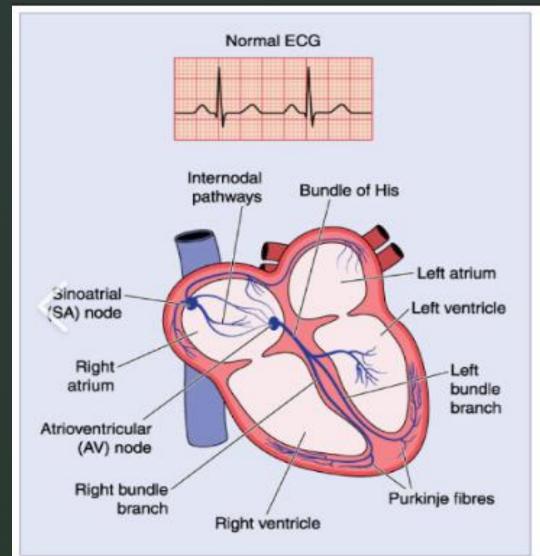
Jaw Thrust

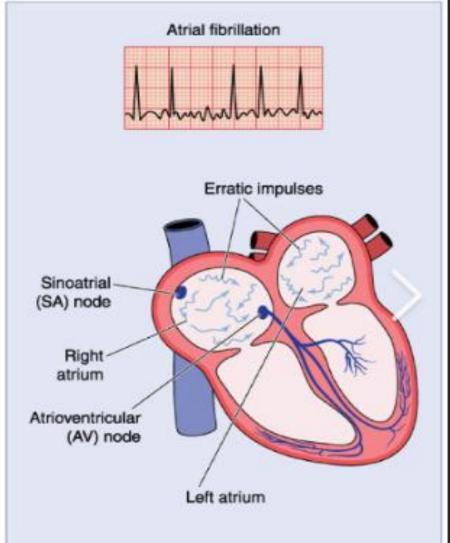


- An alternative to head tilt chin lift
- Technique of choice where there is a strong suspicion of cervical spine injury (e.g. RTA, falls, drowning or diving accidents)
 - Place fingers posterior to the mandibul of jaw and apply upward and forward pressure
- Hold mouth slightly open using thumbs to displace chin inferiorly

Defibrillation: A Hard Reset



Shock stops chaos, it doesn't "restart" a flatline. Presenter Note:
 "The mantra is: Shock, then immediately resume compressions.
 Don't delay."

The Reversible Causes: H's and T's

- Hypovolemia
- Hypoxia
- Hydrogen ion (acidosis)
- Hypo/Hyperkalemia
- Hypothermia
- Tension Pneumothorax
- Tamponade
- Toxins
- Thrombosis (Coronary/Pulmonary)

While you're doing BLS, your mind should be running through this checklist for when ACLS arrives.

When to Stop

- Review TOR criteria (ROSC)
 - Transfer of Care
 - DNR
 - Futility
- This is a team decision, guided by protocols and clinical judgment. It's one of the hardest parts of our job.

Basic TOR Rule (for Medical Cardiac Arrest)

- Unwitnessed arrest by EMS or bystanders
- No shockable rhythm detected (e.g., asystole or PEA)
- No return of spontaneous circulation (ROSC) after full resuscitative efforts
- CPR duration exceeds 20 minutes without improvement
- Secure airway confirmed (e.g., via waveform capnography)
- End-tidal CO₂ (ETCO₂) < 10 mmHg despite effective CPR
- Patient is ≥18 years old

ROSC achieved: what next?

- Post-Cardiac Arrest Care (P-CAC).
- Getting a pulse back is just halftime. The next 72 hours determine neurological outcome.

P-CAC: Preserving Brain function

- Focus on 3 pillars
 - Optimize Hemodynamics/Ventilation. MAP > 65mmHg
 - Targeted Temperature Management (TTM).
 - Early Coronary Reperfusion

Case Study:

• 55-year-old male collapses in the clinic waiting room. You are the first to arrive. He is unresponsive. You see him take a loud, gurgling gasp. What are your next 5 steps, in order?"

Answer

- Ensure scene safety
- Check for response/breathing
- Call for help/AED
- Check carotid pulse <10s
- Begin high-quality chest compressions

Take-Home-Message

- 1. C-A-B! Compressions are king.
- 2. QUALITY matters: Push hard, push fast, allow full recoil, and minimize interruptions.
- 3. CPR is a bridge to definitive care and neurological recovery.
- 4. Don't forget the patient after you get a pulse back.
